WHAT IS THIS PRODUCT?

Type: The product is a share class of the Teilfonds Flossbach von Storch - Foundation Defensive sub-fund, which is part of the Teilfonds Flossbach von Storch fund, a Luxembourg investment fund (fonds commun de placement – FCP) that has been established in the form of an umbrella fund and is subject to Part I of the Luxembourg Law of 17 December 2010 (Law of 2010), as amended, and thus qualifies as a UCITS. The assets and liabilities of each sub-fund are segregated by law.

Term: The product has an unlimited term. Notwithstanding this, the product may at any time be liquidated by the Management Company. As a rule, investors can redeem their units on any Luxembourg banking day except 24 and 31 December. The manufacturer may suspend redemption if exceptional circumstances make this appear necessary when investor interests are taken into account.

Objectives:

The objective of the investment policy of the Flossbach von Storch - Foundation Defensive (the "sub-fund") is to achieve reasonable growth in the sub-fund currency while taking into consideration the risk involved for the investors and sustainability principles. The criteria used to select investments are value, the risk-return ratio and sustainability. The sub-fund is actively managed. No index is used for comparison purposes. Depending on the market situation and appraisal by the fund management, the sub-fund generally has the possibility to invest in equities, money market instruments, certificates, bonds of all types, including zero coupon bonds and variable-interest securities as well as other structured products (e.g. reverse convertible bonds, warrant-linked bonds, convertible bonds), target funds, derivatives, cash and fixed-term deposits. The certificates are for legally permitted underlying instruments, such as equities, bonds, investment fund units, financial indices and currencies. The equity quota is limited to a maximum of 35 per cent of net sub-fund assets. The sub-fund may invest up to 20 per cent of its net assets indirectly in precious metals (gold, silver, platinum). In the interests of risk diversification, no more than 10 per cent of the sub-fund's net assets may be invested indirectly in one precious metal. Units in target funds will be acquired only up to a maximum limit of 10 per cent of the sub-fund's net assets. The use of derived financial instruments ("derivatives") is planned in order to achieve the aforementioned investment objectives, as well as for investment and hedging purposes. The current sales prospectus provides detailed information on the above and other investment opportunities available to the sub-fund. As a rule, investors can redeem their units on any Luxembourg banking day except 24 and 31 December. Unit redemption can be suspended if exceptional circumstances make this appear necessary when investor interests are taken into account. This sub-fund may not be suitable for investors that want to withdraw their capital from the sub-fund within a period of 3 years. This unit class distributes the income it generates to investors. The sub-fund promotes environmental and social characteristics as defined in Article 8 of Regulation (EU) 2019/2088. Flossbach von Storch follows a holistic sustainability approach across the group: As a long-term investor, Flossbach von Storch attaches importance to companies dealing responsibly with their environmental and social footprint and actively counteracting negative impacts of their activities.

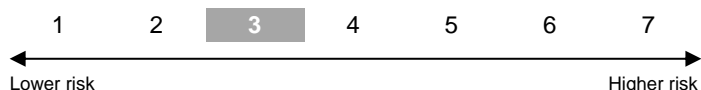

Intended Retail Investor:

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for a minimum of 3 Years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Summary Risk Indicator

The summary risk indicator ("SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.

Be aware of currency risk. You will receive payments in the base currency (EUR) so the final return you get will depend on the exchange rate between the base currency of this product and your own currency which may fluctuate. This risk is not considered in the indicator above.

Unusual market conditions could arise, for example, due to currency, creditworthiness, price, counterparty, liquidity and interest rate risks, as detailed in the sales prospectus.

WHAT HAPPENS IF FLOSSBACH VON STORCH INVEST S.A. IS UNABLE TO PAY OUT?

The sub-fund assets are segregated from the assets of the Management Company. The Depositary is responsible for holding the assets of the fund in safekeeping. If the Management Company defaults, it will have no direct financial effect on the sub-fund. In addition, the sub-fund assets are segregated from the assets of the Depositary, which reduces the risk of the sub-fund suffering a loss if the Depositary defaults. There is no investor compensation or guarantee scheme if the Management Company or the Depositary defaults.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

Recommended minimum holding period: 3 Years

The recommended holding period for the sub-fund is 3 years, as the sub-fund invests for the medium term. Investors can sell their units upon demand on any valuation day (as defined in the sales prospectus).
